- September Programs: 3 Family Law Workshops w/ 39 attendees: Small Claims Clinic w/ 6 attendees; 1 proctored exam; Grand Jury Orientation held on Sept. 16 with 20 attendees. Law Library participated as exhibitor at ICAP's Annual Meeting held on Sept. 27 and 57 attendees stopped by RCLL's display table.
- Staff: A part-time library assistant position opening in Riverside has been posted on our website. The position was left vacant by Cherilyn's resignation who will be working for Western University Health Sciences Library as a full time Asst. Circulation Supervisor. Mariah Clark was hired to fill the administrative position left vacant by Beverly.
- Staff Retreat went well. The morning session was on effective communication skills w/ a focus on effective listening skills. The afternoon program was Tools for Challenging Patrons; Safety & Security at Our Library. Staff watched the Run. Hide or Fight video which brought up the discussion regarding the need to conduct a safety and emergency evacuation drill for the library. Director will contact the County and/or the City.
- CCCLL Legislative effort: B&P §6348.4 Sale or lease of realty was enacted and goes into effect January 1, 2015.
- Indio Branch: anticipated move to the new county law building is Feb. 1 or early January which is contingent upon installation of furniture/equipment; conducted an inventory of items that need to go to the new building, reallocated or discarded, and those that will go to County surplus. A large painting of Gary C. Scherotter, a highly respected attorney in the legal community in the Desert, will be rehanged in the new facility.
