# F. Suspension of Library Privileges Policy

The Board suggested to change the proposed policy limiting the appeal/review of the decision to suspend library use privileges to the Director. Judge Levine suggested to contact the Police Department regarding holding a class on how to handle homeless/vagrants who comes into the library. Also provide information on homeless shelters to give and not simply kicking them out.

### G. Victor Miceli Law Library Parking Lot

The Director will send out the letter to the Pritchard Bldg. Property Management Company to inform their tenants about permit-only parking and offer them a discounted annual fee to rent parking spaces with attached copy of the parking license agreement. The Board suggested to have the permit-only parking set up by July 1st and to have everyone on staff trained to handle the permit-only parking application processing, fee collection, and towing call-out authorization.

## H. Acceptance of the March 2016 & April 2016 Financial Reports

Acceptance of the March 2016 & April 2016 Financial Reports was moved by Joe Myers, seconded by Robert Dunn, voted upon and motion carried. Robert Dunn asked why the interest income on investment line item on the report is showing a loss.
