A. Acceptance of November 2, 2018 Meeting Agenda

B. Acceptance of Minutes of October 5, 2018 Regular Meeting

C. Director's Report

IELLA clinic held on October 16 in Riverside had 12 attendees. This clinic is designed to provide free legal assistance on matters involving family law, tenant's rights/evictions, wage garnishments/collections, restraining orders (DV and Civil).

Two library tours held for UCR Ext. paralegal program had 42 combined total number of students in attendance.

MCLE Crush @ RCLL programs held on October 2nd & 4th had 49 combined total number of attendees. We had 7 registered for all 8 programs, 42 registered for individual programs. We received positive feedback about the programs content and speakers.

National Pro Bono Week programs included:

Free Legal Clinic held on October 25th had 42 combined total number of attendees (30 in Temecula, 8 in Riverside, and 4 in Indio).

Debunking Child Support Myths program held on Oct. 23 by Patty Rich in Riverside had 11 attendees. Family Law Clinic held in Indio on Oct. 24 had 3 attendees.

Legal Resource Expo held on October 24th in Riverside had 25 attendees. The program participants included IELLA, Inland County Legal Services, Family Justice Center, Riverside Superior Court Self-Help Center, Department of Child Support Services, and Participatory Defense (a new organization that offers support to families of those who are facing criminal charges).

D. Ratification of 2018-2021 MOU with SEIU Local 721

Ratification of Tentative Agreement with SEIU deferred to next month's meeting.

E. Strategic Direction and Long-Term Plan for the Law Library Building

Robert Dunn suggested to defer discussion on this item to next month's meeting when the Board President is present.
