## Overview

The Riverside County Law Library is the only public law library in the County and serves more than 2.4 million residents. With the current budget of approximately \$1.8 million, the Law Library provides free access to current collection of legal materials, professionally-trained legal information services staff, public education programs, as well as quality continuing legal education classes. The Main library, named after its long-time Board President, the Honorable Victor Miceli, is located in downtown Riverside. The Indio branch is in the first floor of the County Law Building located at 82-995 Highway 111. The Temecula Law Resource Center, a satellite branch with a relatively small print collection and a core collection of electronic legal materials, is located inside the Ronald H. Roberts Temecula City Public Library.

The Riverside County Law Library, unlike the typical public library, receives no income from taxes, special bond issues or local government appropriations. It is primarily funded by a small portion of the County's civil court filing fee. It is a County Special District effectively functioning as an independent public agency organized under the California Business & Professions Code Section 6300 et.seq.. It is governed by a seven-member Board of Trustees composed of community judges and attorneys who serve without compensation. The Riverside County Board of Law LibraryTrustees, through its leadership and strong commitment to public service, makes free and open access to legal information resources, programs and services possible for every citizen in the County.

#### Governance

The Riverside County Board of Law Library Trustees is a local public agency existing and functioning pursuant to Chapter 5 of Division 3, Section 6300 et. seq. of the California Business & Professions Code. It governs the Riverside County Law Library in accordance with said provisions of law and is composed of seven members consisting of five judges of the Superior Court or their designees, the Chairman of the Board of Supervisors or its designee, and one member of the State Bar, appointed by the County Board of Supervisors, whose principal office is located in the County of Riverside.

The goal of the Board of Law Library Trustees for Riverside County is to make available to the judiciary, State and County officials, members of the State and local Bar, and all County residents, current legal materials, modern facilities, and adequately trained staff, which will enable them to perform the highest level of research and practice.


## **Funding Source**

The primary source of funding for California county law libraries comes from a small portion of the county's civil court filing fee. By law, the Administrative Office of the Courts make monthly distributions from superior court filing fees to the law library fund in each county in the amounts described in the California Business & Professions Code §6321 & §6322.1. The amount collected for civil filing fees varies from county to county. In Riverside County, the Law Library receives, in general,




\$32 for every civil lawsuit filed. In the past several years, approximately 90% of the total law library revenue is derived from court civil filing fee.

California county law libraries have been experiencing a decline in their filing fee revenue for several years since 2008-2009 fiscal year. While recent numbers have shown a reduction in the rate of decline for many counties including Riverside, 65% of county law libraries in the state are currently operating at a deficit.



In Riverside County, the total revenue collected through filing fees was \$1,670,878, down 7% from the last fiscal year. Filing fee revenue makes up 90% of the law library's total revenue this fiscal year. The other 10 % of revenue are from interest income, rental income, copier income, sales and library services income.

Funding of county law libraries continue to be a major concern in California. The Council of California County Law Librarians, with the help of its lobbyist, continually advocate for legislation to increase the portion of filing fees that fund county law libraries, as well as find alternative sources of funding. Thanks to the tireless advocacy efforts of the Council and the support of State legislators, the 2020-2021 State Budget signed by Governor Newsom included \$7 million one-time General Fund to backfill the County Law Libraries for lost revenue due to the reduction in civil case filings from the COVID19 Pandemic. The Riverside County Law Library received \$640,612.00, a percentage of this one-time General Fund based on the percentage lost in its filing fee revenue due to the COVID19 Pandemic.

## **Mission Statement**

To enable everyone in Riverside County to perform the highest level of research and practice through free and open access to the law.



#### Highlights of the Year

#### Service

The Law Library continually finds ways to facilitate and improve access to current collection of legal materials, modern facilities, and knowledgeable staff to assist with legal research and practice for Riverside County residents. Fiscal year 2020-2021 is a year like no other, the Law Library was closed to the public from mid-March 2020 through mid-June 2021. However, the Law Library effectively transitioned to online services that enabled library patrons to have remote access to legal databases, reference assistance, public programs, legal research and MCLE classes.

- 1,161 patron inquiries answered including reference & research related questions
- 8 MCLE classes held (7 hrs. of participatory credits) with 101 attendees
- 2 Library tours were held for 36 individuals which included students from UCR and Riverside City College
- 266 YouTube subscribers and 1,172 views of library's YouTube videos
- 1,045 eNews subscribers with 28% engagement rate
- 28 % increase in Instagram followers (from 441 to 565)
- ❖ 3.7 % increase in Facebook followers (from 504 to 523)
- 9.7 % increase in Twitter followers (from 184 to 202)

The Law Library continued offering relevant and practical programs to include Minimum Continuing Legal Education (MCLE) programs for the legal community. It continually seeks new opportunities to collaborate with community groups, public agencies, the courts, local Bar Associations and law library associations. However, due to the COVID-19 Pandemic, the annual programs sponsored by the local Bar Associations, the courts and county agencies, that the Law Library had participated in past years, did not materialize. The Law Library began offering its public programs, legal research and MCLE classes virtually using Webex and Zoom meeting platforms.

#### PROGRAM OFFERINGS

#### FAMILY LAW WORKSHOPS


The Riverside County Superior Court's Family Law Facilitator's evening workshops on marital dissolution, default judgments, order to show cause, etc., were held online due to COVID-19 restrictions.

#### ▲ LAWYERS IN THE LIBRARY

The free legal clinics held once a month, in partnership with the Desert Bar Association were suspended due to COVID-19 pandemic.

#### FREE LEGAL CLINICS

4 free legal aid clinics held which served 22 county residents.



#### Collection

This fiscal year, the Law Library completed the bar coding of its collection in its downtown Riverside location. The total number of books in the Law Library's collection is 71,775, a 68% increase from last fiscal year's 42,742. The huge difference in the number of books between these two fiscal years reflects the number of books that were bar coded and added into the system. The total collection includes 57,033 volumes in Riverside; 14,305 volumes in Indio and 437 volumes in Temecula. There were 2,519 items withdrawn from the collection this fiscal year resulting from titles replaced with newer editions. In addition to LexisAdvance, Westlaw, CEB OnLaw and Wolters Kluwer Cheetah, the Law Library provides free access to 1,863 titles on Hein Online, 1,500 law reviews on LegalTrac, 350 full text publications on EbscoHost including Nolo Press titles.

This fiscal year, the Law Library acquired a subscription to FastCase which enabled county residents remote access to cases, statutes, regulations, court rules, constitutions, and other primary law materials for all 50 states. It also added to its



collection the Lexis Digital Library which allows county residents remote access to full-text and searchable eBook collection of LexisNexis treatises, deskbooks, practice guides, formbooks and statutes.

The Main Library contains the largest print collection which includes California, Federal, and national-scope law resources, as well as superseded and historical materials. It maintains a collection of local City and County codes and ordinances. The library's collection of practice materials is limited to California, Nevada and Arizona.

The Indio Branch has a collection of approximately 14,304 volumes of California and selected Federal materials. The collection in Indio, while it does not exactly duplicate the Main Library's collection, consists of key print and electronic resources needed for effective legal research.

The Temecula Law Resource Center has a relatively small collection of about 437 volumes and access to core collection of legal databases including LexisAdvance, Westlaw, HeinOnline, LegalTrac, EbscoHost, Forms WorkFlow, CEB OnLaw. Wolters Kluwer's Cheetah, and Lexis Digital Library. The law books are housed in a designated *Law Resources Collection* within the general circulating collection of the Ronald H. Roberts Temecula Public Library. All print materials are California-specific.

The Law Library was closed to the public from March 14, 2020 through fiscal year ending June 30, 2021 due to the COVID-19 Pandemic. However, the Law Library rapidly implemented changes to allow county residents remote access to its legal databases including LexisAdvance, Westlaw, HeinOnline, Nolo Titles on EbscoHost, CEB OnLaw, and FastCase. It also converted its Lexis Titles print subscription to Lexis Digital Library subscription, thereby enabling county residents to access and check-out Lexis eBooks remotely.

The Law Library has an art collection of more than 50 art pieces including paintings, prints, photographs, and sculptures. The art pieces are on display both in Riverside and Indio. Most of the paintings are watercolor and by California artists, primarily from Riverside County.

### Information Technology

The Law Library is committed to providing cost-effective information technology infrastructure that supports the legal information and research needs of its county residents and enables them to keep up with recent changes in the law, legal research and practice.

The Riverside County Law Library hosts six public computer workstations in its downtown Riverside location and six public computer workstations in its Indio branch. The Law Library maintains 12 staff computer workstations and laptops across all branches; 2 servers (1 staff/private, 1 public); copiers/printers in each branch (4 in Riverside, 2 in Indio); and a publicly accessible wireless network in Riverside and Indio locations.


Successfully balancing information technology costs while designing a strategic roadmap for service upgrades and expansions is an integral part of planning for the future. Library user feedback on the law library's information technology resources remains an important part of this process. This fiscal year, the library upgraded its staff and public computers, and added a server to support staff working remotely from home. Investing and allocating funds for information technology infrastructure and support continues to be a key investment point for the Riverside County Law Library.




# Community Engagement

#### Website & Social Media

The Law Library launched its new website in March 2021. The completely redesigned website has an integrated web-accessibility compliant features, easy to navigate user-interface, as well as relevant and up-to-date content.



The new website received 289,686 pageviews this fiscal year, 66.5% increase from the last fiscal year. The number of website visits during fiscal year 2020-2021 shows that 52% are views of the Law Library's homepage and 15% are views of the Legal Database page. The chart below shows the top 10 most popular pageviews of the library's website:





The library had 523 Facebook followers and 202 Twitter followers during 2020-2021 fiscal year. The library stepped up its efforts to increase community engagement through its social media networks. In addition to Facebook and Twitter accounts, the Library currently has 565 Instagram followers, a 28% increase from the previous fiscal year.

#### Public Programs & Special Events

The Law Library is committed to providing access to legal information to members of the legal community and the public, and will continue to offer legal research classes, public educational programs on law-related topics, and minimum continuing legal education (MCLE) programs for attorneys and paralegals. However, during fiscal year 2020-2021, all inperson programs and classes were halted due to the COVID-19 pandemic. The Law Library made a quick transition to offering online programs and classes. The following online programs held in 2020-2021 fiscal year includes the following:

- \* RCLL librarians hosted a Virtual Legal Trivia held on July 15, 2020 with 8 registrants and 4 attendees.
- Oh No! I Got a DUI, What is Going On? Presented by Robin Johnson was held on August 17, 2020 and had 5 attendees.
- Estate Planning: Beyond the Basics presented by Andrea Shoup was held on August 26, 2020 and had 10 attendees
- Voting Basics program presented by the Riverside County Registrar of Voters' office was held on September 22.
- Investigate the Internet, a media literacy program presented by Jenna Pontious was held on September 29, 2020 and had 11 attendees.
- Virtual Ballot Measure Info Session presented by League of Women Voters of Riverside was held on October 1, 2020 and had 12 attendees.
- Our Time is Now (by Stacey Abrams) Virtual MCLE Book Talk and California Voting Rights Act presentation by Naree Chan, Deputy City Attorney for Oakland was held on October 16, 2020 and had 10 attendees.



Virtual presentation on the *California Votings Rights Act* by Naree Chan highlighted the importance of voting in the 2020 Presidential Election.



- The Law Library celebrated National Law Day (May 1st) with a week-long series of program promoting the 2021 theme: Advancing the Rule of Law NOW. The celebration included the following events:
  - o *Just Mercy (by Bryan Stevenson) Book Discussion* held on April 26 had 9 attendees. One hundred and one copies of the book were handed out to *Book to Action* program participants.
  - National Law Day Proclamation presented by County Board of Supervisor Chair Karen Spiegel at the April 27 Board Meeting.





- o A *Post-Conviction Relief Program* presented by Joshua Knight of the Riverside County Public Defender's Office, was held on April 29.
- o True Justice: Bryan Stevenson's Fight for Equality, an HBO Documentary film screening held on April 30 had 8 attendees.
- o An Afternoon with Obie Anthony, Founder & Executive Director of Exonerated Nation, shared his story of transforming his experience as an exoneree to building a community that provide safety, stability, and healing to wrongfully convicted Californians. This program, made possible by the Book to Action grant was held on May 1st and had 8 attendees.
- As a California State Bar approved MCLE provider, the Riverside County Law Library offers free and low-cost MCLE courses on specific topics to help attorneys and paralegals earn continuing legal education credits and meet their MCLE compliance requirements. In addition, the Law Library has subject-specific MCLE programs on CDs & DVDs available for attorneys and paralegals to check out and earn self-study credits. Only a few MCLE materials was circulated during fiscal year 2020-2021, a huge drop from last fiscal year's number of 1,472, due to COVID-19.


#### **Collaborations**

- ❖ Family Law Workshops The Victor Miceli Law Library has for several years made its meeting space, equipment and staff available to the Riverside Superior Court Self-Help Center to hold its Family Law Facilitator evening workshops on marital dissolution, child support, order to show cause, and default judgments. The workshops were held at least three times a month from 4:30 pm to 7:30 pm. Similar workshops were held in the Indio Branch in coordination with the Larson Justice Center, Family Law Facilitator's office and Self-Help Probate office. This fiscal year, these workshops were held online due to the COVID-19 pandemic.
- Legal Consultation Clinic The Law Library has for many years collaborated with local attorneys including members of the Southwest Riverside County Bar Association in providing free 15-minute legal consultation to county residents dealing with issues in the areas of family law, landlord-tenant, personal injury, probate, and civil litigation matters. Due to the COVID-19 pandemic, these free legal clinics were not held during this fiscal year.
- ❖ Lawyers in the Library In collaboration with the Desert Bar Association, the Law Library's Indio Branch has in past years hosted a Lawyer in the Library program every second Thursday of the month, from 3:00pm to 5:00pm which is designed to provide free 20-minute legal consultations to county residents dealing with issues in the areas of family law and general civil litigation matters. This program was suspended this fiscal year due to the COVID-19 pandemic.
- ❖ Legal Aid Clinic with IELLA The Law Library has for several years partnered with the Inland Empire Latino Lawyers Association, to hold a legal aid clinic every Tuesday of the month, from 4:00 pm to 7:00 pm. IELLA's volunteer attorneys provide free guidance and assistance with preparing documents in various legal matters including marital dissolutions, custody, visitation, support, paternity, restraining orders, unlawful detainers, and wage garnishments and collections. This fiscal year, these legal aid clinics were put on hold due to the COVID-19 pandemic.
- ❖ ICLS Consumer Debt Collection Clinic The Law Library, in collaboration with the Inland Counties Legal Services, began hosting a consumer debt collection clinic every 2<sup>nd</sup> Tuesday of the month, from 4:00 pm to 7:00 pm. ICLS staff attorneys provide free advice and assistance in legal matters involving consumer credits, medical and student loans, and debt collections. This fiscal year, the workshop was cancelled due to COVID-19.
- \* Tax Law-related Workshop with ICLS In partnership with the Inland Counties Legal Services, the Law Library hosted a free *Taxpayer Clinic* every fourth Tuesday of the month at 3:00 p.m. to assist low-income taxpayers with tax-related matters such *IRS Innocent Spouse Relief & How to Petition for Relief.* This fiscal year these clinics were held online and 23 individuals received free legal aid.
- Pro Se Civil Appeals Workshop In collaboration with the Fourth District Court of Appeals, the Law Library has hosted a civil appeals workshop for pro se litigants. This is a free one and a half hour long presentation on how to handle civil appeals. Research attorney Carmela Simoncini provides an overview of the civil appeals process, from


- determining which cases are appealable and obtaining a record of the trial proceeding to preparing the appellate brief. No workshop was held this fiscal year due to COVID-19.
- Temecula Law Resource Center Established in November 2011, the Law Library's partnership with the City of Temecula made it possible to provide the Southwest Riverside County residents access to current collection of legal materials, legal reference service, legal research and continuing legal education classes, and public legal education programs. The continued success of this partnership has raised the level of public's awareness of the Law Library's value to the communities in the Southwestern region of the County.
- UCR, Extension Paralegal Program For the past several years, the Victor Miceli Law Library has made its legal resource materials, services and staff available to support the legal research education needs of the UCR Extension Paralegal Program students. The Law Library held virtual tours for the paralegal program students.
- ❖ Legal Research for non-law librarians In collaboration with the Southern California Association of Law Libraries, Public Access to Legal Information Committee (PALI) members, the Law Library held a virtual legal research program designed specifically for librarians and staff of public librarians in the Inland Southern California region. The program was held on February 23, 2021 and had 13 attendees.



#### Staff Activities

The Riverside County Board of Law Library Trustees considers its law library staff an important asset critical to providing excellent customer service. Hence, the trustees completely support the staff's professional development and community outreach activities. The staff's diverse educational and cultural background are important elements in ensuring that the Law Library meets the legal information service needs of a community of library users as diverse as the communities of Riverside County. Keeping the Law Library running efficiently for a combined total of 6,260 hours each fiscal year and maintaining the quality of its collection, services, and programs is a collective effort. An annual staff retreat which is usually held in early Spring was not held this fiscal year because indoor gatherings were restricted due to COVID-19. However, on March 31<sup>st</sup>, an all-staff training was held via Zoom to prepare for the reopening of the library to the public for in-person services. Staff was updated on recent changes in library procedures including *Express/Contactless Checkout* procedures of MCLE materials, *Emergency Action Plan*, *Safe Reopening Plan*, and *COVID-19 Prevention Plan*.


